## **ROAD TO \$1 MILLION OFFICIAL CONTEST DETAILS**

The ROAD TO \$1 MILLION promotion (the "Contest") is an event produced by Scientific Games International, Inc. ("SGI") in connection with participating state lotteries ("Lotteries" or "Lottery"). Winners (the "Finalists") are randomly selected by participating Lotteries per individual state Lottery rules. The total number of Finalists depends upon Lottery participation levels. Finalists will receive a Lottery-sponsored trip to Los Angeles to play a non-broadcast, lottery-winners-only contest (the "Game") for the chance to win a cash prize ranging from a minimum of \$1,000 to a grand prize opportunity for one (1) Finalist to win up to \$1 Million. By participating in the Contest, each Finalist agrees all decisions regarding the Contest and Game are within the sole and exclusive discretion of SGI and are final and binding on all Finalists.

To participate in the Contest, eligible participating Lottery ticket holders must:

- 1. Be randomly selected by the participating Lottery in one (1) or more promotional, second-chance drawings from among all eligible entries received during the official entry periods;
- 2. Meet all participating Lottery selection and prize validation requirements; and
- 3. Upon validation, enter the Contest through the participating Lottery's promotional, second-chance website/app following all entry rules established by the participating Lottery. \*

The Contest will take place in Los Angeles, California, in or about the fall of 2021. The specific date and venue of the Contest may be subject to change, updates will be posted on the Lottery's website no later than ninety (90) days prior to the Contest.

The Game will include a total of eight (8) rounds, consisting of six (6) "elimination" rounds (each an "Elimination Round"), one (1) last chance round ("Last Chance Round") and one (1) final grand prize round "(Grand Prize Round"). Each round will take place as follows:

- a) Elimination Round 1: Will reduce the field from twenty-five (25) Finalists to nineteen (19) Finalists, after which the nineteen (19) Finalists will participate in Elimination Round 2. The six (6) Finalists eliminated in Elimination Round 1 win \$1,000 and qualify for the Last Chance Round for a chance to win an additional prize up to \$10,000.
- b) Elimination Round 2: Will reduce the field from nineteen (19) Finalists to fifteen (15) Finalists, after which the fifteen (15) Finalists will participate in Elimination Round 3. The four (4) Finalists eliminated in Elimination Round 2 will win \$2,500 and qualify for the Last Chance Round for a chance to win an additional prize up to \$10,000.
- c) Elimination Round 3: Will reduce the field from fifteen (15) Finalists to eleven (11) Finalists, after which the eleven (11) Finalists will participate in Elimination Round 4. The four (4) Finalists eliminated in Elimination Round 3 each win \$5,000 and the Game ends for each of these Finalists.

- d) <u>Elimination Round 4:</u> Will reduce the field from eleven (11) Finalists to eight (8) Finalists, after which the eight (8) Finalists will participate in Elimination Round 5. The three (3) Finalists eliminated in Elimination Round 4 each win \$7,500 and the Game ends for each of these Finalists.
- e) Elimination Round 5: Will reduce the field from eight (8) Finalists to five (5) Finalists, after which the five (5) Finalists will participate in Elimination Round 6. The three (3) Finalists eliminated in Elimination Round 5 each win \$10,000 and the Game ends for each of these Finalists.
- f) <u>Elimination Round 6</u>: Will reduce the field from five (5) Finalists to three (3) Finalists, after which the three (3) Finalists will participate in the Grand Prize Round. The two (2) Finalists eliminated in Elimination Round 6 each win \$25,000 and the Game ends for each of these Finalists.
- g) Last Chance Round: After the conclusion of Elimination Round 6, the Last Chance Round will be conducted, consisting of the ten (10) Finalists eliminated in Elimination Round 1 and Elimination Round 2. One (1) of the ten (10) Last Chance Round Finalists will win an additional \$10,000; one (1) of the ten (10) Last Chance Round Finalists will win an additional \$7,500; one (1) of the ten (10) Last Chance Round Finalists will win an additional \$5,000; and seven (7) of the ten (10) Last Chance Round Finalists win no additional cash prize and the Game ends for each of the Last Chance Round Finalists.
- h) Grand Prize Round: After the conclusion of the Last Chance Round, the Grand Prize Round will be conducted, consisting of the three (3) remaining Finalists. One (1) of the three (3) Grand Prize Round Finalists will win \$1,000,000; one (1) of the three (3) Grand Prize Round Finalists will win \$100,000; and one (1) of the three (3) Grand Prize Round Finalists will win \$50,000. At the conclusion of the Grand Prize Round, the Game ends for each of the Grand Prize Round Finalists.

The total Contest prize pool shall consist of \$1,311,000 and be allocated as follows in accordance with the details set forth above:

## **Additional Rules and Procedures:**

All Contest rounds will be audited by an independent auditor.

Contest Cash Prizes will be paid in lump sum cash payments.

The minimum age requirement to participate in the Contest and play the Game is eighteen (18) years old. If a Finalist does not wish to play the Game, the Finalist shall assign a proxy to play on their behalf. If the Finalist does not timely assign a proxy on his or her behalf, SGI shall assign a proxy. A proxy must be eighteen (18) years of age or older to play the Game.

Selected Finalists who are contacted and fail to provide all information requested by a participating state Lottery (e.g., age verification, address verification, signed publicity/liability release and affidavit as to identity) in a timely fashion will forfeit their prize to travel to Los Angeles and their opportunity to participate in the Contest, and the Lottery may select an alternate Finalist.

Prizes are not for resale and are not transferable.

Taxes are the sole responsibility of each Finalist.

Neither the Lottery, SGI, nor other companies directly associated with the Contest shall be responsible to entrants or to any other person for data entry errors resulting from or caused by the entering, keying or mis-keying of the required ticket information by entrants.

Employees of the Lottery, SGI or other companies associated with the Contest, as well as members of their immediate families (spouses, parents, siblings and children) and household members of each such employee, are not eligible to participate in the Contest.

All decisions regarding technical difficulties, mechanical failures, or human errors, including but not limited to the premature reveal of any game material or elements, the malfunction of any piece of stage equipment or electronics or the failure of any audio equipment, in connection with the Contest in Los Angeles will be determined by SGI in its sole discretion and shall be final and binding on all Finalists.

SGI reserves the right to change, add to, delete from, modify or amend these Contest details at any time at its sole discretion, subject to the approval of the participating state Lottery.

Odds of being selected as a Finalist vary by participating state Lottery depending upon the number of eligible entries received and the number of Finalists prizes available.

The payment of Contest cash prizes to Finalists during the Game is the sole responsibility of SGI. All Contest cash prizes are not considered won by a Finalist, and are not payable unless and until SGI's Drawing Manager and the independent Game auditor certify that the Contest has been conducted appropriately and in accordance with the Official Promotion Contest and Security Procedures, that a Finalist has validly won the Contest cash prize award pursuant to the Official Promotion Contest and Security Procedures and is entitled to receive the Contest cash prize award. Participating state Lotteries shall have no liability for any cash prizes awarded to Finalists in the Contest.

FAILURE TO COMPLY WITH ANY OF THE OFFICIAL GAME RULES AND GUIDELINES, PROMOTION PROCEDURES, CONTEST PROCEDURES, INDIVIDUAL GAME GUIDELINES, ANY OTHER GUIDELINES, OR CODES OF CONDUCT SET FORTH BY SGI, MAY RESULT IN A CONTESTANT'S DISQUALIFICATION AT SGI'S SOLE AND ABSOLUTE DISCRETION AND OR THE REVOCATION OF ANY PRIZE WON.
